September 2017

This month's activities resulted in Station 36 responding to **68** calls for service; **46** incidents were for emergency medical and **22** incidents were suppression-related. Station 36 responded to **32** calls within our section of the Village of Inverness and **8** calls in the other side of Inverness. The District logged **8** calls within the Southeast Area and **14** incidents in all other contract areas for an overall total of **90** calls.
