FIRE DEPARTMENT MONTHLY REPORT

October 2017

This month's activities resulted in Station 36 responding to **76** calls for service; **44** incidents were for emergency medical and **32** incidents were suppression-related. Station 36 responded to **23** calls within our section of the Village of Inverness and **11** calls in the other side of Inverness. The District logged **5** calls within the Southeast Area and **19** incidents in all other contract areas for an overall total of **100** calls.

Calls of Interest:

October 5th: Tender 36 responded on a box alarm into Fox River Grove. Tender 36 provided 3200 gallons of water prior to being released.

November 1st: Engines 36, 81 and 23, Tower 85, Tenders 36 and 37, Ambulances 23 and 82 and Battalion 8 responded for a garage fire at 1450 Banbury (behind Inverness Village Hall). While en-route, police reported an attached garage fully involved with fire. E-36 arrived on scene to find the front end of a Ford truck, along with the front area of a large wood frame garage, involved in fire. A primary search of the house was performed with significant smoke found on every level of the house, but no fire or victims were present. The fire was contained to the garage.
