FIRE DEPARTMENT MONTHLY REPORT

August 2015

This month's activities resulted in Station 36 responding to **84** calls for service; **46** incidents were for emergency medical and **38** incidents were suppression-related. Station 36 responded to **39** calls within our section of the Village of Inverness and **7** calls in the other side of Inverness. The District logged **10** calls within the Southeast Area and **16** incidents in all other contract areas for an overall total of **100** calls.


Calls of Interest:

Crews stretched and charged a hand line and evacuated houses adjacent to 196 Glamis. NiCor arrived on scene and stopped leak. Crews used meters to monitor multiple homes for gas.

08/24/15 15-00655 833 Ela Rd. Inverness Car –V- Tree

Companies responded to a tree that had fallen on a car on Ela road. On arrival crews found an SUV with moderate front end damage and one person with minor injuries. A tree that was next to the road fell on the vehicle that was traveling around 35mph.
