FIRE DEPARTMENT MONTHLY REPORT

September, 2019

This month's activities resulted in Station 36 responding to **77** calls for service; **53** incidents were for emergency medical and **24** incidents were suppression-related. BLS care was rendered on **11** incidents while ALS care was rendered on **34** calls. The remaining medical did not require medical care. Station 36 responded to **32** calls within our section of the Village of Inverness and **6** calls in the other side of Inverness. The District logged **8** calls within the Southeast Area and **10** incidents in all other contract areas for an overall total of **95** calls.
