FIRE DEPARTMENT MONTHLY REPORT

October 2016

This month's activities resulted in Station 36 responding to **102** calls for service; **61** incidents were for emergency medical and **41** incidents were suppression-related. Station 36 responded to **26** calls within our section of the Village of Inverness and **10** calls in the other side of Inverness. The District logged **6** calls within the Southeast Area and **10** incidents in all other contract areas for an overall total of **118** calls.

Calls of Interest:

October 3rd - Engine 36 responded into South Barrington with the BCFPD for an AFA at Willow Creek Church. The alarm was upgraded to a structure response for smoke coming from the roof. E 36 was sent to the roof and assisted Hoffman Truck 22 with overhauling a section of roof that had been on fire due to construction work. E36 also assisted with ventilation inside the building, before being released.

October 13th - Engine 36 responded to 134 W. Hillside, Barrington for a house fire. E36 assisted in extinguishing a fire in the exterior walls of a house.

October 20th - Ambulance 36 was dispatched into Hoffman Estates on a report of a structure fire. A36 secured a water supply for the attack engine. Next they were assigned to overhaul. Upon completion of those tasks, they took in a Code One in District 23.

October 25th - Chief May responded to 1151 E Dundee. This was a restaurant with a fire in the walls.

October 27th - Ambulance 36 responded into Hoffman Estates for a laundry room fire. Crew was assigned 'Initial Rapid Intervention Company' by Command. While in this position, crew placed a portable ladder to the second floor and shut-off the gas coming in to the house.
