FIRE DEPARTMENT MONTHLY REPORT

May 2016

This month's activities resulted in Station 36 responding to **68** calls for service; **41** incidents were for emergency medical and **27** incidents were suppression-related. Station 36 responded to **27** calls within our section of the Village of Inverness and **6** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **14** incidents in all other contract areas for an overall total of **91** calls.
