FIRE DEPARTMENT MONTHLY REPORT

November 2015

This month's activities resulted in Station 36 responding to **99** calls for service; **53** incidents were for emergency medical and **46** incidents were suppression-related. Station 36 responded to **44** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **14** calls within the Southeast Area and **12** incidents in all other contract areas for an overall total of **125** calls.

Engine 36 responded for a kitchen fire in a multiple unit dwelling. Upon arrival, E-36 was assigned RIT.

11/16/15 # 15-0896 1124 Whytecliff, Palatine – Garage Fire

District 36 units arrived on scene first and deployed a 1 ¾" attack line into the garage. Crews were able to contain the fire to the contents and keep it from impinging on the structural components of the garage. Approximately 700 gallons of water were used to contain the fire.

E 36 was assigned ventilation on arrival, followed by air monitoring.
