## **FIRE DEPARTMENT MONTHLY REPORT**

### **February 2016**

This month's activities resulted in Station 36 responding to **66** calls for service; **43** incidents were for emergency medical and **23** incidents were suppression-related. Station 36 responded to **25** calls within our section of the Village of Inverness and **7** calls in the other side of Inverness. The District logged **12** calls within the Southeast Area and **17** incidents in all other contract areas for an overall total of **75** calls.

### **Calls of Interest:**

#### **02/02/16 #16-0074 343 N. Elmwood - South East Area, Flooding**

On February 2<sup>nd</sup> E 36 responded to the South East area to assist E16 on a house that was flooding. E36 arrived at 343 N. Elmwood and found that heavy rain falling on ice packed culverts was diverting water toward the home. E36 broke several ice dams to assist in the flow of water. E36 contacted Palatine Township, who brought out several sand bags to assist in controlling the flow of water.

#### **02/04/16 #16-0080 Roselle & Pheasant Inverness, Truck Fire**

On February 4 E36 was dispatched to a garbage truck on fire. The entire cab area was on fire. E36 deployed a 2 ½ " line and extinguished the garbage truck with tank water. The garbage truck ran on compressed natural gas. These tanks were located and shut down.



**2/15/16 #16-00101 & 16-00102 Inverness**

Station 36 companies responded to two cardiac arrests, seven hours apart. The first was at Rosewood Care Center and the second at 1901 Baldwin. Palatine companies assisted at both incidents and Bn-15 was also at the nursing home.

**02/26/16 #16-00126 911 W. Panorama VOP Structure Fire**

Engine and Ambulance 36 responded into the village of Palatine on a report of a structure fire. The fire was in an apartment building on Panorama Drive. Palatine Rural units were assigned to complete a primary search of the upper floors
