This month's activities resulted in Station 36 responding to **88** calls for service; **59** incidents were for emergency medical and **29** incidents were suppression-related. Station 36 responded to **39** calls within our section of the Village of Inverness and **2** calls in the other side of Inverness. The District logged **13** calls within the Southeast Area and **7** incidents in all other contract areas for an overall total of **108** calls.
