FIRE DEPARTMENT MONTHLY REPORT

March 2015

This month's activities resulted in Station 36 responding to **71** calls for service; **35** incidents were for emergency medical and **36** incidents were suppression-related. Station 36 responded to **25** calls within our section of the Village of Inverness and **4** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **9** incidents in all other contract areas for an overall total of **89** calls.

3/4/15 #00181 5201 Carriageway Rolling Meadows Structure Fire

Engine 36 responded into Rolling Meadows for a fire in a multifamily dwelling.
