FIRE DEPARTMENT MONTHLY REPORT

December 2016

This month's activities resulted in Station 36 responding to **95** calls for service; **60** incidents were for emergency medical and **35** incidents were suppression-related. Station 36 responded to **47** calls within our section of the Village of Inverness and **9** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **17** incidents in all other contract areas for an overall total of **121** calls.
