FIRE DEPARTMENT MONTHLY REPORT

September 2016

This month's activities resulted in Station 36 responding to **81** calls for service; **50** incidents were for emergency medical and **31** incidents were suppression-related. Station 36 responded to **30** calls within our section of the Village of Inverness and **4** calls in the other side of Inverness. The District logged **9** calls within the Southeast Area and **15** incidents in all other contract areas for an overall total of **105** calls.
